MINUTES OF EMERGENCY SERVICES DISTRICT 2
MEETING JANUARY 6, 2026

Call to order – At 5:00pm, Marshall called the meeting to order.

Oath was administered to Commissioner Hayman and Commissioner Culpepper.

Review, discuss & take action regarding the election of the District officers.

Hayman made a motion, seconded by Chrestopoulos for Murphey to become President. Marshall opposed. Motion carried.

Murphey made a motion, seconded by Hayman for Chrestopoulos to become Vice President. Motion carried.

Chrestopoulos made a motion, seconded by Murphey for Culpepper to become Treasurer. Motion carried.

Marshall made a motion, seconded by Chrestopoulos for Hayman to remain as Secretary. Motion carried.

Chrestopoulos made a motion, seconded by Hayman for Marshall to become Assistant Treasurer. Motion carried.

Waterwood Fire & Rescue and Allegiance Ambulance Reports: Reports were given.

Minutes Prior Meeting – Chrestopoulos made a motion to approve the December 4, 2025, minutes, upon fixing a typo on second page. Motion seconded by Hayman and passed unanimously.

Review, discuss & take action regarding the treasurer's report and pay bills

A motion was made by Marshall seconded by Chrestopoulos to pay bills listed. Motion carried.

Review, discuss & take action regarding updating bank account information and signature cards on all accounts to reflect the current board members

A motion was made by Hayman, seconded by Murphey to add Culpepper to bank account. The signature cards reads as follows:

Review, discuss & take action regarding closing the bank account at First National Bank Huntsville and opening a new General account at People's State Bank Coldspring.

A motion was made by Murphey, seconded by Hayman to close the account at First National Bank Huntsville and open a new account at People's State Bank Coldspring. Motion Carried.

Review, discuss & take action regarding updating email accounts to reflect current board members.

A motion was made by Marshall, seconded by Murphey to suspend email accounts for Riley and Schwebach and create one for Culpepper. Motion carried.

Review, discuss & take action regarding contract between SJC ESD2 and Waterwood Fire & Rescue.

A motion was made by Marshall, seconded by Culpepper to table and do a workshop on next Agenda. Motion carried.

Review, discuss & take action regarding contract between SJC ESD 2 and Waterwood Improvement Association, Inc.

A motion was made by Murphey, seconded by Chrestopoulos to table contract pending further negotiation. Motion carried.

A motion was made by Murphey, seconded by Culpepper to form a committee of 2 consisting of Commissioners Murphey and Chrestopoulos, to go to WIA meeting on January 19 to workshop the Agreement with WIA. Commissioner Hayman will be excluded.

Commissioner Hayman abstained. Motion carried.

Commissioner Marshall left the meeting at approximately 6:15 PM.

Hayman made a motion to adjourn the meeting. Motion seconded by Chrestopoulos. Meeting adjourned at approximately 6:22 pm.
