MINUTES OF EMERGENCY SERVICES DISTRICT 2
MEETING MARCH 3, 2026

Call to order – At 5:00 PM, Murphey called the meeting to order.

Minutes Prior Meeting –

A motion was made by Chrestopoulos, seconded by Hayman to approve minutes for February 18, 2026. Motion carried.

Review, discuss & take action regarding the treasurer’s report and pay bills.

A motion was made by Chrestopoulos, seconded by Culpepper to make the following payments:

Hayman abstained. Motion carried.

A motion was made by Chrestopoulos, seconded by Hayman for Brooke Mounce to contact bank and be allowed to conduct administrative tasks for SJC ESD 2. Motion carried.

Review, discuss & take action regarding purchase of new apparatus.

No action taken. The board discussed the grant received by Waterwood Fire & Rescue and possibly getting an extension.

Review, discuss & take action regarding revenue from Waterwood MUD.

No action taken.

Review, discuss & take action regarding exploring new attorney representation.

A motion was made by Chrestopoulos, seconded by Culpepper to extend an offer to Regina Adams as legal counsel under flat rate agreement of \$1,000.00 per month.

Chrestopoulos edited his motion to ask attorney to include in contract to only accept calls and drop ins from board members with prior board approval. Motion carried.

A motion was made by Murphey, seconded by Chrestopoulos to separate Ken Campbell as attorney representation for SJC ESD 2.

Review, discuss & take action regarding accounting software

A motion was made by Culpepper, seconded by Chrestopoulos to purchase QuickBooks Online Simple Start for \$19.00 for the first 3 months and \$38 monthly after. Motion carried.

Culpepper made a motion to adjourn the meeting. Motion seconded by Chrestopoulos. Meeting adjourned at approximately 6:06 PM.
